Training complies fully with Health & Safety Executive guidelines document HSG179 and the PWTAG (Pool Water Treatment Advisory Group) Code of Practice for Swimming Pool Water – July 2021.

Course attendees should ideally have basic experience of pool plant water treatment and testing.

The course fee of £335 + VAT is payable in advance on submission of application.

The course is endorsed by the **Institute of Swimming Pool Engineers (ISPE)** and supported by water testing specialists, **Lovibond Tintometer**. Course delegates are provided – by courier - with a current copy of the **Pool Water Treatment Advisory Group (PWTAG) manual 'SWIMMING POOL WATER : TREATMENT AND QUALITY STANDARDS FOR POOLS AND SPAS'** and a copy of the current **PWTAG 'Code of Practice for Swimming Pool Water – July 2021'**, which is freely available for downloading on the PWTAG website. Flowman has printed it for you as a service to those of you who don't have a printer. The Code provides a model of operation based on PWTAG good practice. Following the Code gives an assurance to operators and the public that the pool meets essential healthy pool operational standards. Included also in the courier package is the very useful, pocket-sized **Lovibond Tintometer booklet on 'Water Treatment & Analysis'**.

The course commences on Zoom at 10am on each of the three Wednesdays and finishes at 4.00pm; there is a period of self-study built in within those times that should be used to revise that day's subject matter and complete a short, online test paper. In order to obtain the certificate, candidates are required to submit a simple pre-course assignment, sit an end-of-course multi-choice format test on Google Forms and are then required to successfully submit a post-course work-based assignment within four weeks of the course end date. Each of those elements contributes to the final mark for certification. You will be provided with full guidance on the use of the Zoom platform and Google Forms from our audio/visual partner company who are also in attendance during the training.

The course has been designed for the pool industry by the PASOQ Education Board, which is made up of active and experienced Tutors / Trainers and Operational Managers. Their remit is to oversee and maintain the standards and quality of the qualification. The long-established pool plant **Technician Certificate** ensures that the theoretical knowledge gained on the course is then firmly underpinned by technical skills and the expertise gained in the plant room environment. This ensures that operators acquire the necessary competencies through suitable and sufficient training, to operate pool plant safely and efficiently. The certificate is valid for five years.

PASOQ Technician Certificate - Revalidation

The course fee of £135 + VAT is payable in advance on submission of application. The PASOQ 1-day Revalidation seminar recognises other 3-days qualifications e.g. ISRM PPO etc. It has been designed to update operatives' knowledge and ensure that the currency of the Technician Certificate is maintained.
